WeBuy rewards buyers for their participation in an ecosystem that, up until now, has failed to recognize their importance. With WeBuy, buyers get rewarded in tokens for their activity on the platform. They are invited to create and manage their own Buyer Referral Network (BRN) that is made up of the sellers that they referred to WeBuy. Their private information is never revealed to sellers or 3rd parties, leaving them in complete control of their privacy.

WeBuy enables sellers to geolocalize potential buyers who have expressed their interest in the sellers' products. This is done by using our groundbreaking "SellMe" feature, coupled with an intuitive advertising system that does not require previous advertising knowledge. WeBuy services are 100% free and will stay free.



GO TO MARKET

To encourage sellers to join the Buyer Referral Networks (BRNs), each seller will receive a joining grant of \$500 from WeBuy in the form of advertisement credits. Income is generated from the seller, based on the fees paid for ads to reach potential buyers. Buyers will be awarded a significant portion of the fee received for agreeing to watch an ad and/or be reached by sellers. The buyers will be awarded the fee in the form of WBY tokens.




SHORT TERM TARGET


